Please note the following:

Only members in good standing shall be eligible to run for office or vote in a Branch election. To run for office, a member in good standing is one whose name appears on the roll of the Branch as a bona fide member of the Branch by May 1st of the election year and remains a continuous member of the branch through the election process; and who lives and/or works within the Branch jurisdiction.

- 1. All elections will be conducted, electronically, using Election Buddy via email or text. If you have NOT provided an email and would like to vote (meeting the above qualifications) please, email me @ naacplufkintx@gmail.com.
- 2. To run for a local branch office, you must be a member by May 1, 2022
- 3. Membership in the NAACP, for purposes of the 2022 Branch Election cycle will be effective on the date the membership is received by the Branch or in the National Office (including online at www.naacp.org)>

Notice of September, October Meeting, and November Election

1. **On Monday, September 26, 2022**, via ZOOM at 6:00 p.m., there will be an election of the Nominating Committee (between 5-15) and the number of at-large members to be elected to the Executive Committee. All members whose membership is current as of 30 days prior to the meeting date may be elected to the Nominating Committee (not more than 2 being officers of the unit(branch)).

- 2. **On Monday, October 24, 2022**, via ZOOM at 6:00 p.m., there will be a report of the Nominating Committee, receipt of Nominations by Petition, and election of the Election Supervisory Committee. All members whose memberships are current as of May 1, 2022, whose membership has remained continuous throughout the election process, and who live and/or work within the unit's jurisdiction, may be nominated for office or as an at-large member of the Executive Committee. To sign a nominating petition, or be elected to the Election Supervisory Committee, a member must be current as of 30 days prior to the October meeting.
- 3. **On November 17, 2022, the election** of officers and at-large members of the Lufkin Branch Executive Committee will be from 4:00 p.m. to 8:00 p.m. using Election Buddy, via email or text. To vote in a Branch Election, one must be a member in good standing of the Branch 30 days prior to the election, November 17, 2022. A form of identification is required.
